

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.littlehousebullies.com and Little House Bullies LLC (“LHB”) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to LHB include www.littlehousebullies.com. The LHB website is a pet supply breeder’s website. By using the LHB website, you consent to the data practices described in this statement.

Collection of Your Personal Information

In Order to better provide you with the products and services offered on our Site, LHB may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase LHB’s products and/or services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) sending us an email message; (c) submitting your credit card or other payment information when ordering and purchasing products and/or services on our Site. To wit, we will use this information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of Your Personal Information

LHB collects and uses your personal information to operate its website(s) and deliver the services/products you have requested.

LHB may also use your personally identifiable information to inform you of other products and/or services available from LHB and its affiliates.

Sharing Information with Third Parties

LHB does not sell, rent or lease its customer lists to third parties.

LHB may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to LHB and they are required to maintain the confidentiality of your information.

LHB may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with the legal process served on LHB or the site; (b) protect and defend the rights or property of LHB; and/or (c) act under exigent circumstances to protect the personal safety of users of LHB, or the public.

Tracking User Behavior

LHB may keep track of the websites and pages our users visit within LHB, in order to determine what LHB Services are the most popular. This data is used to deliver customized content and advertising within LHB to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by LHB. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is subject to the limitations of this agreement and is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the LHB website.

Use of Cookies

The LHB website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience features to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize LHB pages, or register with LHB site or services, a cookie helps LHB to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing address, shipping addresses, and so on. When you return to the same LHB website, the information you previously provided can be retrieved, so you can easily use the LHB features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
